CHAPTER 1

1.1. Background of Study

First, the imitation of the mainstream literary tradition; second, the protest against the standards of this dominant tradition concerning social values and rights; and third, self-discovery which aims at a search for identity." (Elaine Showalter, A Literature of Their Own).
